

KORG USA's Blackstar Plug in & Win Contest!

Official Rules

NO PURCHASE NECESSARY. The **Blackstar HT Venue Contest** ("Promotion") takes place beginning at 9:00am EST, October 1st, 2015 and ends at 11:59 PM EST, November 30th, 2015 (the "Promotion Period"). The Promotion is sponsored by Korg USA, Inc., 316 South Service Road, Melville, NY 11747 ("Sponsor"). All federal, state and local laws apply. Void where prohibited.

Eligibility: The Promotion is open to all residents of the 50 United States and Washington D.C. who are at least 18 years old, have reached the age of majority in their state of residence, and who have internet access at the time of the Promotion Period. We will not disclose any personal information regarding names, addresses and other confidential matter.

Selection: One winner will be randomly selected from all eligible entries on the last day of November. Odds of winning will depend upon the number of eligible entries received during the Promotion Period.

Prizes: There will be one (1) prize awarded during the Promotion Period, consisting of one Blackstar HT Club 40 amp, **valued at \$599.99**. All prizes will be awarded as described. No substitution or transfer of prizes, except at the sole discretion of the Sponsor, if the advertised prize becomes unavailable.

Notification of Potential Winners: A Potential Winner will be contacted via email at the end of the drawing. The Potential Winner is required to contact the Sponsor within 5 business days of the drawing.
